- 1. The CoP had a good conversation about the situation with regard to COVID-19 and how it influences their work. The discussion showed that most of the CoP members are experiencing the second or third wave of COVID-19 in their country. Following, the universities either require or encourage the staff to have mostly teaching and meetings online. First year students seem to get more face-to-face teaching than other students. People experience some conflicts about the teaching thus, whether it should be online or face-to-face. In some universities, if you have face-to-face teaching, then the two meters apply, and teachers and students need to wear a mask. Furthermore, increased online teaching is accompanied with higher workload, wherein teachers spend a lot of time on preparation. In this situation it is important to be aware of the distribution of tasks and time allocation. The distribution of tasks is always a challenge.

The pandemic has also encouraged some organisations to evaluate how the situation is affecting everyone – especially women in academia – what will be the effects of the pandemic. Further research will also be conducted in most/all countries on how COVID-19 is affecting other aspects of life. However, some mentioned the important of being aware of how we are researching on COVID-19 and by whom – SSH or STEM? Also, how is this being monitored in countries? It is important to be wary of superficial surveys and research.

- 2. Fiona discussed the online workshop she is planning with her collegues, probably late January 2021. They are interested to have Iceland with them as the country has been on top of equality charts for a long time. The plan is fluid and still in a working process. There will probably be a morning session and talk about gender equality, pay and more, in different parts of the world. - 3. A decision was taken to plan a webinar in December, 2020. It was also decided that the webinar would be for the CoP members, and they could invite interested people from their own organisation. Thus, the webinar would not be open for everyone. Katarina accepted to technically host the webinar. Moreover, Laufey is checking the possibility to pay a guest lecturer for presenting at the webinar. It has to be someone that is interested in GB. - 4. Then it was discussed if a meeting in Iceland in January 2021 is realistic, thus, if the CoP members foresee they can participate at that time. People are not optimistic and said that it looks impossible to travel and the travel restrictions are to heavy. Spring 2021 is considered to be more promising time for a meeting. As the project is suppose to end in April 2021 that might be impossible. However, as the project might be extended for few months, there is a slight chance of planning a meeting next spring. Further information needs to be gathered for that kind of decision. We will discuss this later on.
